Cleaning Methods

- : Avoid direct contact with eyes.
- : Avoid spreading discharged product and keep it from spilling or coming in contact with the ground, waterways, drains and vents.

: Stop a spill if doing so poses no risk. Keep spills contained and soak them up with non-combustible, absorbent materials such as sand, earth, vermiculite or diatomite. Then place them in a container for disposal in accordance with local regulations (see Section 13). Finish cleaning by rinsing the surface with plenty of water and drain to foul drain.
